Do you believe, as we do, that preserving and strengthening our marriages is essential to our serving God effectively? And that traditional marriage is under attack daily from our culture and media? If so, read on - you may want to help with this project.

Judy and I have been conducting marriage seminars both in and outside the state of Missouri since 2000. Ralph & Paula Walker joined us in these efforts in 2005 because we all believe Godly marriages don't happen by accident and that Christian couples sometimes need help in making their marriages work. Additionally, we thought a weekend of instruction, sharing, personal time and socialization with those of similar faith would only help our marriages.

Because of the tax issues involved, we decided to create a separate entity to ensure the legality of all activities. We incorporated under the name of InLight, Inc.

InLight, Inc. is a Non-Profit Corporation in the state of Missouri. Our I.D. # is 83-0469969

InLight, Inc. exists for the sole purpose of promoting marriage and family values through seminars/retreats in various locations. These seminars have been well received and have benefitted many who have attended. It is our goal to be able to conduct two of these seminars per year – in different regions of the country. To date we have focused on retreats for married couples. These weekend seminars require the securing of lodging and meals, which are covered by the registration fees paid for by those attending. Additional costs include materials, meeting rooms, and AV equipment. Due to the generosity of others who are equally interested in this work we have been able to secure most of the equipment we need to conduct these seminars. Our future plans are to broaden our scope to include special retreats for other groups such as teens and parents. For those who want to participate but cannot afford it, we intend to offer scholarships or grants as determined by the board of directors and our resources.

Those who teach these seminars as well as the board of directors of InLight, Inc. serve as volunteers, not employees. None are paid for their services. We will continue to keep costs down by charging all attendees a sufficient amount to cover lodging, meals, and special activities. We do not require help from others in these areas. What we do need is additional help in the following areas of start-up and maintenance:

#### **Continuing Expenses:**

- **Printed Materials** \$250 - \$500 per seminar x 2
- **A/V Fees** \$250 - \$450 per seminar x 2
- **Travel Expenses (For speakers)** \$400 - \$600 per seminar x 2
- **Misc. Expenses** \$100 - \$200 per seminar x 2
- **Website Hosting & Maintenance** \$200 per year
- **Total Yearly Operating Costs** \$2000 - \$3500 (previous years' avg. \$2400)

**Equipment Still Desired:**

- Small Sound System \$800 - \$1000

Because Inlight, Inc. is a registered tax exempt corporation all donations are fully deductible. Any donations are greatly appreciated. We are seeking two different types of donations.

**One Time Donations** – to help cover this year’s operating costs which we believe are extremely low for the work we are doing. These donations will also be used to purchase the few remaining equipment items we need to decrease the rental fees we are now paying for each seminar. The teachers and board of directors have continued to provide financial contributions as well as donate a substantial amount of time because we feel the work is so important. We are seeking a few others who would like to be financially involved in this work.

**Yearly Contributions** – In addition to the one-time donations, we are establishing what we are calling “The 50/50 Club”. We are seeking approximately 50 donors to contribute \$50 per year to take care of our scholarship fund. This will allow us to help between 10 – 25 couples per year with “scholarships”. These donations will be kept separate from donations for operating expenses. The next scheduled weekend seminars are in Howey-In-The-Hills, FL – July 30 – August 1, 2010 and Branson, MO – October 28 – 30, 2011.
